Renter further understands and acknowledges that lifeguards are not responsible for providing supervision; rather lifeguards are responsible for enforcing safety rules and responding to emergencies. Further, Renter and Renter's guests are solely responsible for determining whether they have appropriate swimming skills for any aquatic activity contemplated by this agreement and that the District is not responsible for assessing the skills of any patron. Renter also agrees to follow all pool rules.

Additionally, Renter understands and agrees that children 12 years of age and younger must be supervised at all times by a responsible person, 18 years of age and older and it is renter's responsibility to enforce this requirement. Further, if any guest uses or requires a personal flotation device, renter takes responsibility that this guest will be no more than an arm's length away from someone 18 years and older at all times. Accordingly, renter agrees that he/she shall communicate this requirement to all guests/patrons associated with and attending this event.

Renter agrees to protect, indemnify, save, defend, and hold harmless the District including its officers, officials, employees, agents, and volunteers (collectively "District") from and against any and all liabilities, obligations, claims, damages, causes of action, costs and expenses, (including reasonable attorney fees) which the District may become obligated by reason of accident, injury, drowning, or any member of Renter's group (or caused by a member of the renter's group) arising indirectly or directly in connection with or under this agreement.
